TO THE REGISTERED VOTERS OF CARROLLTON-FARMERS BRANCH INDEPENDENT SCHOOL DISTRICT ("CFBISD"):

Notice is hereby given that the vote centers and polling places listed below will be open from 7:00 a.m. to 7:00 p.m., on November 3, 2020, for voting in the general election to elect two at-large trustees to three-year terms on the CFBISD Board of Trustees.

Pursuant to a Resolution and Order dated October 9, 2015, cumulative voting shall be used at the election to be held on November 3, 2020, and will continue for future elections until otherwise rescinded by the Board.
